



The Whisker Gift Nomination Form

The Whisker Gift is a semi-annual donation of \$500 supporting local shelters and rescue groups, organizations that train therapy, service, and search-and-rescue animals, and national organizations such as the American Society for the Prevention of Cruelty to Animals and the Humane Society of the United States.

The nominated organization must be a public charity granted tax-exempt status under section 501(c)(3) of the United States Internal Revenue Code. In addition, the organization must be in compliance with all state and federal tax laws and must not be in violation of any state or federal charitable solicitation laws at the time of nomination.

To nominate a qualified organization, complete both pages of the Nomination Form and submit via email to info@whiskergifters.com along with a copy of the organization’s audited financial statements for the most recent tax year, a list of board members (including their affiliations, email addresses and phone numbers) and a copy of the organization’s 501(c)(3) verification. Deadlines for nominations are June 1 and November 1 each year for the July and December donations respectively.
